


DESCRIPTION

The TCMT1100 series consist of a phototransistor optically coupled to a gallium arsenide infrared-emitting diode in a 4 pin (single channel) up to 16 pin (quad channel) package.

The elements are mounted on one leadframe providing a fixed distance between input and output for highest safety requirements.






Fig. 2 - Test Circuit, Saturated Operation




Fig. 3 - Switching Times




Fig. 4 - Total Power Dissipation vs. Ambient Temperature




Fig. 5 - Forward Current vs. Forward Voltage




Fig. 6 - Relative Current Transfer Ratio vs. Ambient Temperature




Fig. 7 - Collector Dark Current vs. Ambient Temperature




Fig. 8 - Collector Current vs. Forward Current




Fig. 9 - Collector Current vs. Collector Emitter Voltage




Fig. 10 - Collector Emitter Saturation Voltage vs. Collector Current




Fig. 11 - Current Transfer Ratio vs. Forward Current







Fig. 12 - Turm-on/off Time vs. Forward Current





PACKAGE DIMENSIONS in millimeters








